




The vision of Forman Intermediate History & Pakistan Society (FIHPS) is to study the past, so that we can learn from it and move forward rather than dwelling on the same spot.

Sir Ganga Ram; A Man for All Seasons Saleem Masih Asim

Book Review

The book begins with Sir Ganga Ram's early life. He was born in Gurdwara, as his parents owned no house of their own and could hardly rent one. His outstanding performance earned him scholarships and, at the end, a prestigious post as assistant engineer in Lahore in 1873. When he transferred to a remote place DG Khan in the Punjab, he made the best of bargain and continued his thoughtful planning and creative competence for his surroundings. Ganga Ram completed the difficult project that was assigned to him. Everyone applauded his brilliant success. Even the top officials in the province, the Governor General of India, delighted at Ganga Ram's excellent performance. Because of his sheer dint of mental genius and quality work he produced, Ganga Ram could have specialization in sewerage, drainage and water systems from the Great Britain. After returning to India, he full used what he had learned abroad, and he provided excellent drainage, sewerage and water supply for the old Lahore. Thus, the old diseased, infested and smelly conditions of inner Lahore cleared up. He is called the builder of Lahore and his period is called Ganga Ram's period of architecture, which means low-cost and high-quality architecture. He performed an excellent job for the preparatory work of Delhi Darbar, planned for the British Empire celebrations in January 1903. Lord Curzon was full of praise for Sir Ganga Ram and mentioned his name many times in communications with the British Government in London and to the king of Britain. Ganga Ram could not get a promotion because of professional jealousy and racism. Ever tolerant and wise about the ways of the world, Ganga Ram sought early retirement. This sudden change in Ganga Ram's career gained him an opportunity which diverted his attention to his earlier wish of doing something about the danger of famines in India. He applied his scientific and engineering knowledge and his practical experience to agricultural development. He organized practical solutions which resulted in a campaign acros

His works and buildings stood the test of time and his institutions were still flourishing. Inspired by his ideas and success, some of his friends and admirers build a new hospital in Dehli which is famous and recognized for the advanced research and treatment. Ganga Ram's name continued to be associated with social welfare. He solved the Guru ka Bagh dispute with his timely intervention and setting a bakery for the unemployed young men, was existing example of his concern for the welfare of the ordinary people. Though he died over seventy-eight years ago, his popularity lives on in Indian Sub-Continent. His educational institutions and his hospitals in Lahore and Delhi are still models of charity and development. Some years ago, when there were plans to change the name of Sir Ganga Ram Hospital, Lahore, there was a strong opposition from people in all walks of life regardless of their social, economic and religious position. Ganga Ram's work is a living memorial to his devotion to improve the conditions of the poor. His humanitarian principles and modesty were admired by the people of Punjab. It is difficult not like the author's thought provoking and inspirational expression while highlighting the great and innovative style of Sir Ganga Ram describing his social light and great humanist without mentioning the political impact created on account of his agricultural developments and educational developments in Punjab. Author's deep sightedness is enough much to explore all the aspects of the events described in the book. However, he has highlighted Ganga Ram as innovative, pioneering of social work, great philanthropist and successful agriculturist due to which no doubt Ganga Ram is one of the India's great heroes.

Naming the Silk Road; Empires of Ancient Eurasia

During a course of three and a half millennia, between the late second century before the Common Era (BCE) and the mid-third century of the Common Era (CE), many of the human societies living within the massive Afro-Eurasian world region linked into an interdependent structure of networks via a chain of roads recognized now as the New Silk Road. This "First Silk Roads Era" appeared in the important transregional economic and artistic collaboration matured by people to this point in the past. Although silk was one of the remarkable component assets, that was carried along this web of land and naval routes, what caused this initial reiteration of the Silk Road so vital was the network of non-material "commodities" that existed as a need of commerce. In retrospect, the name appears from the German term die Seidenstrassen, which was coined in the late nineteenth century by German geographer and explorer Baron Ferdinand von Richthofen. These deliberate handling of various terms to label the ancient trade network serve as a direct acceptance by Von Richthofen that, not only were the journeys that connected Han China and the Roman Empire diverse and complicated, divided into "Main Road" and a multiple of subsidiary sections, but they were powerful for both profitable and artistic transfers.

It is interesting to note that most theorists think of globalization as very much a contemporary process whose motives can be found out to the development of European colonial authorities around the world since the sixteenth century but the reality is on the contrary, it was this unusual cultural and organic dispersion that marked the First Silk Road Era as one of the most crucial cycles in ancient world history. After tens of thousands of years of small-scale regional cooperation, it was during the First Silk Road Era that millions of humans inhabiting in diversified associations with an enormous section of geographic space hooked up in a swap system so effective and distinct that, it now looks to be the ultimate illustration of an ancient globalization.

There is no denying the fact that during a cycle of some 350 years between the late second century BCE and the mid-third century CE, equipment and intellectual networks promoted by economic hubs within Inner Eurasia and the Indian Ocean Basin contributed to the Afro-Eurasian world zone into a thriving, vibrant, associated network of the economic, social and cultural effects for all those connected.

Affordable and Clean Energy, Pakistan's Energy Crisis; A Critical Overview

United Nations has designed Sustainable Development Goals (SDGs) that are a collection of seventeen interlinked global goals designed to be a "blueprint to achieve a better and more sustainable future for all." The SDGs were set up in 2015 by the United Nations General Assembly and are achieved by the year 2030. Among the other SDGs, SDGs number seven focuses on "affordable and clean energy for all." There are some alternative ways of energy generations by using which we can save environmental pollution, climate change, global warming, and the huge amount of money that we spent on our traditional ways of energy generation. Pakistan is still depending on the energy sources like oil, coal and gas which are limited, rare, harming the environment and are costly.

There is a dire need to explore the substitutes for these resources. Governments throughout the world are shifting from the energy generation sources of oil, coal, and gas towards much cheaper and environment friendly sources like solar power, wind energy, Mini hydropower plants, etc. We can conclude Pakistan still is far behind from achieving the renewable, affordable, clean and environment friendly energy generation methods. If Pakistan wants to achieve the target of the SDG7 before the year 2030, Pakistan needs some effective policies and practical implementations.


